# WHAT IS ENFORCED





# **Non-Monetary Claims**

- → Handing over movable assets
- → Eviction
- → Obligations to act, refrain from acting or suffer action
- → Reinstatement of employee to work

### WHO ENFORCES



#### Issuance of enforcement order

→ In case of directly enforceable titles (court decisions, settlements, arbitral awards, notarial deeds etc.)

#### Overseeing of enforcement activities





#### Issuance of enforcement order

→ In case of trust-worthy documents (invoices, bills of exchange, cheques etc.)



# Financial Agency (FINA)

**Enforcement activities in enforcement against** monetary assets

E-auction for sale of immovable property



## **Enforcement Administrators**

Employed as judicial bailiffs: public servants

- → Enforcement carried out by court
- → Seizure of movable property
- → Eviction

# Procedure's duration depends on the type of enforcement

#### **Possible duration**

- → Enforcement over monetary assets
- → Enforcement against movable assets
- → Enforcement against immovable property
- → 2 months
- → Several months
- → More than a year

### **HOW MUCH DOES THE PROCESS COST**



# Costs depending on the type of enforcement, the value of the claim and the number of procedural acts, with fixed maximum amounts
