## **Non-Monetary Claims**

- → Handing over movable assets
- → Transfer of real estate/chattel
- → Eviction
- → Obligations to act, refrain from acting or suffer action
- → Precautionary measure (seizure or security)

## Performance of enforcement duties

- → Enforcement of court judgments
- → Collection of directly enforceable receivables
- → Selling of repossessed items etc.



# Enforcement Officers (bailiffs)

- → Officials who carry out enforcement duties:
- → enforcement inspectors
- → senior enforcement inspectors
- → chief enforcement officers
- → Competence in individual enforcement cases
- → Wide and independent competences/decision-making powers
- → Duty to enforce enforceable titles without questioning their content
- → Guided by principles (appropriateness), obligation to act properly and impartially and to make reasoned decisions

#### **HOW LONG DOES THE PROCESS LAST**



- → Requirement for expediency
- Enforcement carried out
   without undue delay
   Possibility for postponement
- → Timely scope depending on matter and circumstances

Average processing time:

7.3 months in 2019
