## WHAT IS ENFORCED





## **Non-Monetary Claims**

- → Handing over movable assets
- → Eviction
- → Obligations to act, refrain from acting or suffer action

### **WHO ENFORCES**





- → Servicing of judicial and extrajudicial documents
- → Enforcement of enforceable titles
- → Enforcement of any other duty assigned under the law

Operating within the geographical jurisdiction of the Appeal Court he/she is appointed

### Fees for servicing of documents

→ Four zone pricing system

	Zone	km	Fee
1	ZONE A	0 - 12 km	35,00 €
2	ZONE B	13 - 32 km	55,00 €
3	ZONE C	32 – 62 km	73,00 €
4	ZONE D	62 + km	95,00 €

VAT 24% not included

#### Fees for enforcement acts

> Seizure/Conservatory arrest 660,00 € + VAT 24%

In case of confiscation of more than one immovables/ships/aircrafts:

- 1st asset: whole of the above price
- 2<sup>nd</sup> to 4<sup>th</sup> asset: 1/2 of the above price
- 5<sup>th</sup> to 10<sup>th</sup> asset: 1/3 of the above price
- 11th or more assets: 1/4 of the above price.
- > Any other enforcement act: 300,00 € + VAT 24%

#### **General fees**

- → Inquiry in public registers: 30,00 € + VAT 24%
- → Fee for witness participation:
  - in case of posting up/denial to receive a document: 10,00 € + VAT 24%
  - in enforcement acts: 50,00 € + VAT 24%
