# WHAT IS ENFORCED

---



## Monetary Claims

- Child support
- Cash debts
- Utility debts



## Non-Monetary Claims

- Handing over movable assets
- Eviction
- Obligations to act, refrain from acting or suffer action
- Child transfers

# WHO ENFORCES

---



## Bailiff (Enforcement officer)

→ **Duties**

- Enforcement of court decisions and enforceable documents (exclusive responsibility)
- Service of documents

→ **Independence**

→ **Appointment by Minister of Justice**

# HOW LONG DOES THE PROCESS LAST

---



**Long and complex process  
with multiple steps**

**Duration depending on several factors**

(whether the debtor has foreclosable assets,  
whether they challenge enforcement, etc.)

# HOW MUCH DOES THE PROCESS COST



## Bailiff's (enforcement officer) fees

- Reimbursement of costs
- Service charges and commissions

Value of the claim	Service charge
1-100 000 HUF	9000 HUF
100 001 – 1 000 000 HUF	9000 HUF + <b>3%</b> of the part of the claim which is above 100 000 HUF
1 000 001 – 5 000 000 HUF	36 000 HUF + <b>2%</b> of the part of the claim which is above 1 000 000 HUF
5 000 001 – 10 000 000 HUF	116 000 HUF + <b>1%</b> of the part of the claim which is above 5 000 000 HUF
10 000 001 HUF and above	166 000 HUF + <b>0,5%</b> of the part of the claim which is above 10 000 000 HUF

Value of the claim collected	Enforcement commission
1 – 5 000 000 HUF	<b>8%</b>
5 000 001 – 10 000 000 HUF	400 000 HUF and <b>6%</b> of the part of the collected sum which is above 5 000 000 HUF
10 000 001 HUF and above	700 000 HUF and <b>3%</b> of the part of the collected sum which is above 10 000 000 HUF

- Enforcement for the performance of a specific act: 15 000 HUF
- Cost of serving a document: 7500 HUF

## Standard cost allowance

- 5 000 HUF: enforceable amount up to 500 000 HUF
- 1%: enforceable amount exceeding 500 000 HUF
